Two Geotechnical Engineering Case Studies

This is a forensic case study of two geotechnical reports done by the same geotechnical engineer on two different plats that had similar results. Each type of foundation on each individual lot, i.e., full, Lookout or no basement, was indicated. Two houses, one on each subdivision, resulted in litigation: one settled, the other went to trial.

At trial, Plaintiff's expert testimony conformed to "Accepted Engineering Practice to a Reasonable Degree of Engineering Certainty" and was reinforced with citations. The defendant's expert did not conform to "Accepted Engineering Practice," did not provide citations and could not do so under cross-examination: Jury award to the Plaintiff.

A second case study (if time allows) of construction of a structure too close, 12± feet, to an unstable 1:1 side slope resulting in litigation twice: a criminal misdemeanor and a civil action for damages.
